 - |UserdefinedfixedfeeID renamed Fixed Fee ID
 - Fixed Fee ID renamed |FixedFeeID
3. Invoices query subject
 - added all invoice attributes
4. Expenses query subject
 - added expense report records and expense report status history

5. Financial Analysis query subjects

- added Billable task assignment time
- new record type FinAnnRecType 50, default is not enabled

6. Added calculation to convert UTC to local date/time

- Task assignment daily time distribution query subject –added columns Local start time and Local end time for converting UTC time to the time zone of the task assignment

7. Workgroup query subject

- Added Workgroup OBS (outline breakdown structure)

Upgrade instructions and additional information

1. Import the model.zip:

- a) On the client machine where the Changepoint Cognos Sync Utility is installed, start the **Changepoint Cognos Sync Utility** from **Start** menu, and sign in with your user ID and password.

Note:

- The user who runs the Changepoint-Cognos Sync Utility must have Cognos administrator privileges.
 - The client machine where the Changepoint Cognos Sync Utility installed must have a network connection to the Changepoint web server and database server.
- b) Copy the applicable model.zip from the patch to a folder that can be accessed by the Changepoint-Cognos Sync Utility.
 - c) In the **Changepoint-Cognos Sync Utility** dialog box, click **Import Revision**.
 - d) In the **Open** dialog box, select the appropriate version of the model.zip file, and then click **OK**.
 - For Changepoint SA, select model.zip
 - For Changepoint PPM, select Model-ITD.zip

2. Update the model with a new revision:

- a) In the **Changepoint Cognos Sync Utility** dialog box, click **New Revision**. The **New Revision** dialog box appears.
- b) In the **Comments** field, enter a comment.

- c) Select the options as required:
 8. To import configurable fields, select the **Include configurable field delta** check box.
 9. To import new or changed field labels or page content strings, select the **Include language string delta** check box.
- d) Click **Publish Model**.
3. Publish an unsecured model based on the latest revision when applicable:
 - a) In the **Changepoint Cognos Sync Utility** dialog box, double-click the latest revision.
 - b) In the **Model Detail** dialog box, click **Publish unsecured model**.
 - c) The unsecured model is published to a package with the default name of ChangepointUnsecured.
4. Upgrading the database:
 - a) Open SQL Management Studio with sufficient rights.
 - b) Execute 1900131000.sql against the Changepoint database.
5. Send an email notification to the user group. Advise report creators to open each of their reports in Cognos report design tool, and then follow the prompts to accept the changed package.
